The Nisqually Red Wind Casino in partnership with MacDonald Miller and Casino Air announce the installation and engineering of an air purification system.

Olympia, WA — 12/8/2020 — Today, the Nisqually Red Wind Casino in partnership with MacDonald Miller and Casino Air announced the installation and engineering of a new Casino Air Purification System. The purification system enables the casino to filter and destroy various viruses, tobacco smoke, bacteria, mold, mildew, pollen, and the COVID-19 virus. “The Nisqually Red Wind Casino has always been committed to the health and safety of our guests and team members, but now more than ever,” said Cheebo Frazier, General Manager. “We couldn’t be happier to take the lead and be the first Casino in this region to invest in this innovative technology in response to the COVID pandemic,” said Frazier. “Anything we can do to make our facility as safe as possible for everybody visiting are big steps in the right direction.” Since reopening its doors in May, after a 60-day closure due to COVID-19, the Casino has implemented many new health and safety protocols, including reduced capacity of occupants in all areas, temperature checks for guests, team members, and vendors upon entry, strict mask requirements, and increased cleaning and sanitation practices, just to name a few. With those measures implemented, the management’s attention as turned to airborne mitigation efforts. Installation is set to be complete this month.

Utilizing Innovative Technology to Enhance Guest Experience

Molecular oxidizers, a patented ‘double-dielectric-barrier micro-discharge’ technology creates activated oxygen. Activated oxygen instantly oxidizes and destroys virus and bacteria as well as eliminates odors and chemicals in ventilated spaces.

Once activated, the oxygen is then injected into the HVAC system and circulated throughout the casino. The molecular oxidizers work in tandem with a filtration system that uses electronic polarization to trap airborne contaminants like tar, nicotine, paper ash and other microscopic particles that normally pass through non-electronic filters.

This unique filtration method is twice as effective as a HEPA filter at .007 microns and up to 45 times as effective as most pleated filters.
